## Tax Effective Giving

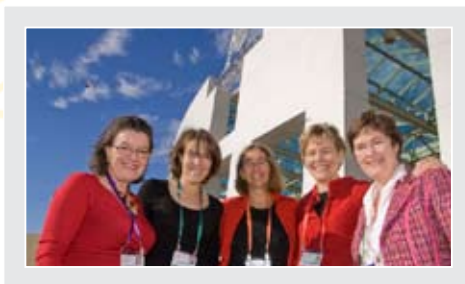
The Australian Government has made it possible for donors to claim a tax deduction for their donations to the Scholarship Fund.
